In particular, the discussions will focus on the implementation of the recently adopted OSCE Ministerial Council Decisions on Strengthening Efforts to Combat All Forms of Child Trafficking, Including for Sexual Exploitation, as well as Other Forms of Sexual Exploitation of Children (MC.DEC/7/17) and Strengthening Efforts to Prevent and Combat Child Trafficking, Including of Unaccompanied Minors (MC.DEC/6/18). In addition, the panel will look into the rationale and the applicability of the 'social path' of identification of victims of human trafficking, including in mixed migration flows.
